PART II: SUBJECT OF THE CONCESSION

II.1. Name of the subject of concession: The subject of the Contract for establishing a public-private partnership is implemented as a concession for collecting, transporting, and disposal of communal waste on the territory of the Municipality of Tearce, which acquires the right to payment from the users of the service.
II.2. Nature and scope of the concession: A public-private partnership which is implemented as a concession of a public service for waste management, including collecting, transporting, and disposal of communal waste with a scope for all the legal entities and persons within the territory of the Municipality of Tearce.
II.3. Explanation of the justification of the concession and allocation of the objectives: According to the legal regulations, i.e., the Law on Local Self-Government, the Law on Public Cleanliness and the Law on Waste Management, the maintenance of public cleanliness and waste management is a responsibility of the municipality and is under the direct competence of the Municipality of Tearce. The Municipality of Tearce does not have the financial, technical and human resources to establish a public utility

company. According to the report for preliminary analysis of the basic elements for establishing PPP for collection, transport and disposal of municipal solid waste in the Municipality of Tearce, prepared by the Municipality of Tearce, the municipality and PE Hygiene do not have the financial capacity to perform the legal competence, i.e., municipal waste management. Due to the inability to perform their obligation, i.e., to offer their citizens a public service: collection, transport, and disposal of municipal waste, they decide to search for a private partner who will perform the public service on their behalf.

The implementation of the PPP project is expected to achieve the following goals:

- Reduction of the amount of waste generated;
- Reduction of environmental pollution;
- Influencing the improvement of human health;
- Waste selection;
- Influencing public awareness about waste and its proper selection;
- Increasing the number of users of the service, i.e., all households to use the service.

II.4. Place/location of the implementation of the concession:

The location of the implementation process is on the entire territory of the Municipality of Tearce

According to the Feasibility Study for justification of the establishment of a public-private partnership agreement for collection, transport, and disposal of municipal waste in the Municipality of Tearce, the minimum value of the concession fee is 2% of the price charged from the service users. This percentage is a criterion for selection of the most favorable private partner, i.e., the offerors will bid positively. The offeror who will offer the highest percentage will be selected as the most favorable offeror, if it satisfies the other conditions.
